5.2 NZ NBL Life Membership Nomination - Criteria & Process

- Robust discussion was had
- The board agreed in principle with the decision paper and the life membership criteria

• The board are reviewing the awards that currently exist and would like to incorporate the NBL life membership award into the review to understand where it sits holistically

5.3 Integrity Code Pilot (ICP) MoU

- · Decision paper taken as read
- Belinda confirmed that the Sport Integrity Commission is seeking six National Sporting Organisations (NSOs) to participate in a pilot program for adopting the Integrity Code. NSOs selected for the pilot will receive additional support and resources from the Commission, enabling BBNZ to better understand the requirements and plan the necessary steps to meet the minimum standard
- Participation in the pilot is expected to enhance BBNZ's reputation with Sport New Zealand
- Belinda also noted that there is a plan in place to allocate this work to an existing part-time staff member, ensuring dedicated support for the initiative.
- It was suggested that Volleyball and Hockey are two other NSOs likely to be involved in the pilot

5.4 NZ National Age Group Players user pays capped at \$5,000 in 2025
